# "Can't wait for #rovinj2019" Photo Contest"

#### **CONTEST TERMS & CONDITIONS**

Before entering the contest, please read these rules.

### **SECTION 1. Organizer/Administrator**

The Organizer of the contest "Can't wait for <u>#rovinj2019</u>" is Rovinj Tourist Board (Iva Damuggia, info@rovinj-tourism.hr, +385 99 494 8601, OIB: 6131572451), hereinafter referred as the Organizer. The contest will take place on Facebook (Rovinj Tourist Board), Instagram (@lovelyrovinj) and Twitter (@rovinjofficial) profiles.

The Administrator of the Facebook, Instagram and Twitter pages, through which the contest is conducted and is held accountable for the participants' personal data on behalf of the Organizer, is Envy d.o.o. (Marina Krizman, info@envy.hr, +385 1 6064 600, OIB: 35359755966), hereinafter referred as the Administrator.

#### **SECTION 2. Duration**

The "Can't wait for <u>#rovinj2019</u>" photo contest is taking place for the duration of 21 days starting on 10/11/2018 at 5:00 PM CET until 10/30/2018 at 11:59 PM CET.

### **SECTION 3. Rules**

Rules of the contest will be posted on the website <a href="www.rovinj-tourism.hr">www.rovinj-tourism.hr</a> and/or Rovinj Tourist Board Facebook page (Notes section).

## **SECTION 4. Eligibility**

- **4.1.** The right to participate in the contest have all adult individuals who: are registered on Facebook and are fans of the Facebook Page Rovinj Tourist Board (<a href="https://www.facebook.com/rovinjtouristboard">https://www.facebook.com/rovinjtouristboard</a>), and/or are registered on Instagram and are followers of the Instagram Page @lovelyrovinj (<a href="http://www.instagram.com/lovelyrovinj">http://www.instagram.com/lovelyrovinj</a>), and/or are registered on Twitter and are followers of the Twitter Page @rovinjofficial (<a href="https://twitter.com/rovinjofficial">https://twitter.com/rovinjofficial</a>).
- **4.2.** Owners, management and employees of the Organizer and their immediate family can't participate in the Contest, as well as any other enterprises involved in the organization of the contest.

## **SECTION 5. Participation rules**

**5.1.** To participate in the contest, users are required to access their Facebook, Instagram or Twitter profiles, be familiar with the rules posted on the website (<a href="www.rovinj-tourism.hr">www.rovinj-tourism.hr</a>) and/or posted on the Rovinj Tourist Board Facebook page (Notes section) and follow the instructions: share the most recent photo/s of their vacation in Rovinj during 2018 on their Instagram or Twitter profile and/or post the photo/s to their Facebook profile, using the hashtag <a href="wrovinj2019">#rovinj2019</a>. <a href="wrovinj2019">#rovinj2019</a> is the official hashtag of this contest. All photos that enter the contest must be of original creation and under the sole ownership of the participant. All photos that enter the contest must be shared/posted within the start and ending date of the contest.

Each participant can offer an unlimited number of photos within the contest, but only those who meet the earlier stated criteria will be considered. Photos cannot be edited subsequently (adding the hashtag <a href="#">#rovinj2019</a> on earlier posts is not considered eligible to enter the contest).

**5.2.** The Administrator reserve the right to, at any time, disqualify participants for the duration of the contest: If the participant violates these rules or leaves inaccurate personal information when giving data processing consent; If a participant uses fake profiles to enter the contest. All profiles under reasonable suspicion or were created for the sole purpose of participating in contest will be considered fake. Reasons include but are not limited to: lack of profile photographs, lack of friends/followers or nonresponding to the direct message within 24 hours; If the participant is in any way trying to influence the contest; If the participant posts vulgar, offensive or inappropriate comments. In this case, the Administrator may disable commenting and/or ban/block the participant from Organizer's Facebook, Instagram and Twitter profiles. This is also covered by the overall rules of stated social networks.

### **SECTION 6. Award**

The award includes a vacation in Rovinj in 2019 for two participants who meet all the criteria of the contest and are chosen as winners by the three members of the Rovinj Tourist Board's jury. The award <u>does not include</u> transportation to the destination. Two winners will be selected in accordance with the rules laid down in sections 4 and 5.

### **SECTION 7. Contest results/Awards collection**

The names of the winners will be published on the Facebook (Rovinj Tourist Board), Instagram (@lovelyrovinj) and the Twitter profile (@rovinjofficial) within 8 days after the end of the contest. By these rules, the winners agree to have their name revealed on stated social networks.

The winners are obliged to inform the Administrator (via inbox of stated social networks) the necessary information (name, surname, email address, mobile number) within 5 days after the end of the contest to collect the award. In case the winners don't respond within mentioned time, they will lose the right to claim it.

The winners will cooperate with the Administrator for collecting the award and administering all necessary documentation.

Obtaining the prize will terminate all obligations of the Organizer towards the winners. The award cannot be exchanged for money or any other prize. The Organizer will not give any additional awards except for those stated in these rules.

### **SECTION 8. Personal data protection**

By entering the contest, the participants expressly agree that the Administrator (as the Data Processor) can process the data for contest purposes. The Administrator and the Organizer will keep the participants' personal data up to 120 days after the contest completion.

The winners' data will be kept for 11 years in accordance with the accounting law.

The Administrator will process all data according to the personal data regulation.

Submitting data for this contest is voluntary. If a participant considers that the data processing conflicts with the protection of his or her privacy, or may conflict with the law, he or she can contact the Organizer or the Personal Data Protection Agency and request an explanation.

The winners of the contest expressly agree that the Organizer and the Administrator may use their name, address and photo in articles and reportages about the award collection without any compensation, with the purpose of public announcement of the contest results.

Each participant has the right to request access to their personal data; to request correction or deletion of their personal data; to limit or object the processing of their data. The participants have the right to withdraw the data processing consent at any time, without affecting the lawfulness of the processing based on the previously given consent, before it was withdrawn.

The Administrator will not disclose or assign data to third parties other than the Organizer. The Administrator may transfer participants' personal information to countries outside Croatia, including the United States, but they will still fall under the adequate protection and safeguards required by the local law.

#### **SECTION 9. Exclusion**

Facebook, Instagram and Twitter are not responsible for the contest, have no connection with it and are relieved of the responsibility for each participant. Facebook, Instagram and Twitter don't sponsor or manage the contest nor is the contest in any way connected with Facebook, Instagram or Twitter. By entering the contest, the participants are consenting to give their data to the Organizer, not Facebook, Instagram or Twitter.

### **SECTION 10. Acceptance of the rules**

Participants accept all the rights and obligations stated in these rules.

The contest may be terminated only in the situations for which the Organizer is not responsible, or which could not be prevented, eliminated or avoided. In that case, the Organizer is relieved of all possible liabilities incurred towards participants.

The Organizer, or any company engaged by the Organizer for the execution of the contest, does not assume any liability and will not remove or compensate the costs, damages or losses due to delays or lack of contest's overall performance.

After 60 days from the contest completion, the Organizer will not receive any complaints regarding it.
